Terms and Conditions of the Agreement

- To insure your date to be saved an agreement must be signed and the deposit received as soon as possible. We accept payment by check or cash. The deposit is refundable. Rental fee is due 45 days prior to scheduled event
- 2. Rental is from midnight to midnight the day of the event unless individual arrangements have been made.
- 3. All events will conclude by 11:00 p.m. to comply with the city noise ordinance.
- 4. Key may be picked up during business hours Tuesday thru Friday, 10:00 a.m. to 5:00 p.m. or Saturday 10:00 a.m. to 3:00 p.m., except holidays, at Jim Stubblefield Furniture or arrangements may be made to procure a key from Bobette Balser Wilson, 573-473-5930, or Mary White Littrell 573-581-4893 or 573-473-2521. Key deposit is \$25 and is refundable when key is returned.
- 5. If you cancel more than 30 days before your event, you will get a full refund. If you cancel more than 14 days, but less than 30 days, you will forfeit the deposit (\$300). If you cancel less than 14 days from the event you will forfeit the rental fee. The deposit will be refunded.
- 6. Deposit will be returned within two weeks of use provided the facilities have been properly cleaned and nothing is damaged or missing and the key is returned.
- 7. You will be billed for any damages not covered by the \$300 deposit.
- 8. Applicants must be a minimum of 21 years of age to reserve this facility.
- 9. Agreements may be revoked if the intended facility use is misrepresented.

Rental Conditions

- 1. You may decorate the facility any time on the day of your event. Decorations must be flame retardant to protect the building. Use of glue, nails, staples or adhesive tape is forbidden. Only painter's tape may be used to hang decorations.
- 2. You may NOT use any type of glitter or confetti. Your deposit will be retained if evidence is noticeable after the event.
- 3. No vehicles/trailers of any kind may be driven inside the stable.
- 4. If straw or hay bales are to be used for seating, loose straw and hay must be swept up and bagged. Leaf blowers are not allowed to blow hay or straw out of the building.
- 5. Tables and chairs may not be removed from the building without prior approval.
- 6. No illegal gambling is allowed on the premises.
- 7. No candles, open flames or fireworks are allowed.
- 8. Smoking is prohibited on the grounds, inside and outside the building. Smoking is only allowed outside the fence
- 9. Agreements cannot be transferred, assigned, or sublet.
- 10. Parking is available on the street. On site parking will be allowed at our discretion.
- 11. Young children must be under the direct supervision/control of an adult 18 years of age or older.
- 12. Simmons' Stable Preservation Fund, Inc. reserves the right to change, adjust or delete any rules and regulations where health and safety of the patrons is affected, before, during or after the event.
